Announcing the Competitive Entrance Examination and fixing the number of places available for admission into the 1st Year of Master of Agro-Food Process Engineering, Master of Maintenance and Production Engineering and Master of Industrial Chemistry and Environmental Engineering of the Engineering Cycle of the National School of Agro-Industrial Sciences (ENSAI) of the University of Ngaoundere for 2023/2024 academic year.

examinations into Faculties and Schools of State Universities in Cameroon for the academic year 2022-2023;

On the proposal of the Rector of the University of Ngaoundéré,

DECIDES:

Article 1: (1) The Competitive Entrance Examination for admission of students into the 1st Year of Master in Agro-Food Process Engineering, Master in Maintenance and Production Engineering and Master in Industrial Chemistry and Environmental Engineering of the Engineering Cycle of the National School of Agro-Industrial Sciences (ENSAI) of the University of Ngaoundere for the 2023/2024 academic year shall take place on the 09 and 10 September 2023.

(2) This Competitive Entrance Examination is opened to Cameroonians of both sexes and also to foreigners resident in Cameroon.

(3) Admitted candidates shall pay the appropriate tuition fees as prescribed by law.

Article 2: The numbers of places available in the first-year programmes of the Engineering Cycle of the National School of Agro-Industrial Sciences of the University of Ngaoundere for the Academic year 2023/2024 are as follows:

Article 3: Candidates for the examination should be holders of one of the following qualifications:

- 1. For candidates for the Agro-Food Process Engineering or for the Industrial Chemistry and Environmental Engineering:
- The University Diploma of Technology (DUT) in Agro-Food Processing;
- First degree in either Chemistry; Biochemistry, Microbiology, Biology, Environmental Sciences or Food Sciences.
- Any other equivalent qualification that is related to the program.
- 2. For candidates for Industrial Maintenance and Production Engineering Programme
- The University Diploma of technology (DUT) in Industrial Maintenance and Production;
- First degree in either Physics; Electrical or Mechanical Engineering; or Sciences and Technology;
- Any other equivalent qualification that is related to the programme.

Article 4: The complete application file should comprise of the following documents:

- (a) An application form completed online and downloaded;
- (b) A certified photocopy of birth certificate dated not more than three months old;
- (c) A certified true photocopy of certificates/diplomas;
- (d) 4 recent passport-size photographs;
- (e) A certified copy of candidate's National Identity Card
- (f) A non-conviction certificate dated not more than 3 months;
- (g) A medical certificate issued from a government hospital dated not more than 3 months
- (h) A receipt of payment of the sum of twenty thousand into the bank account ECOBANK CAMEROON Ngaoundere no 26017-01207980501-20 ECOBANK as participation fees in the Entrance Examination.
- (i) An A4 size self-addressed and 500 francs stamped envelope.

<u>Article 5</u>: Application shall be strictly online through the website http://concours.ensai.univ-ndere.cm, which will be available from 01 July 2023. Completed files should be deposited on or before the 07 of September 2023 latest, at any of the following places:

- The Ministry of Higher Education/Department of Higher Education Planning;
- Any of the 10 Regional Delegation of Secondary Education;
- The University of Ngaoundere antenna in Yaounde (Immeuble Resistance Construction: Quartier Fouda).
- The Secretariat of the National School of Agro-Industrial Sciences (ENSAI) Ngaoundere;
- Any of the Rectorates or Vice Chancellor's Office of the 11 (eleven) State Universities.

Article 6: 1) Candidates with properly completed files shall be examined in four subjects in any of the following examination centres: BAMENDA, BAFOUSSAM, BUEA, DOUALA, NGAOUNDERE, MAROUA and YAOUNDE.

2) Candidates seeking admission into the Agro-Food Process Engineering and Industrial Chemistry and Environmental Engineering program shall be examined on the following subjects:
